Study Set-up

Local Approval

Registration

Complete the registration form for access to the Redcap database

- For security reasons, registration is not immediate.
- You will receive your registration details and account activation instructions within 4 working days.

Introduction

Publications

We aim to publish articles on the service evaluation and would like you to be a collaborator in these papers.

Certificates of participation will be provided at the end of the service evaluation.

Electronic Data capture

We will be using REDCap, which is hosted on servers within QMUL's Data Safe Haven to provide the study database and surveys.

Patient recruitment

We are aiming to recruit 500 participants.

Operation Notes

When you enter your patient data into REDCap, an operation note will be created automatically. This can be cut and pasted into your own electronic notes or other document.

Weekly recruitment diary

We need to collect data on recruitment to inform a power calculation for the planned nationwide study. If patients don't want to give consent to participate in the service evaluation, please ask them to complete the anonymous feedback section on the back of their paper consent forms and use their responses to complete the weekly emails you will receive with the following survey questions.

Patient surveys

Patients will complete follow-up surveys 3 weeks and 4 months after surgery. The surveys will be automatically sent to them by email or text message and should take less than 5 minutes to complete.

Patient Information

- If possible, a copy of the information leaflet should also be sent to the patients with their appointment letter.
- But definitely provide patients with a copy of the patient information leaflet when they arrive at your department for their surgery.
- Prior to surgery, give patients time to read the information sheet and ask questions about the study.
- It is important to explain that this Service Evaluation will not affect their treatment in anyway.

Patient Consent

Both E-consent and printable consent forms are available

E-consent

- Patients who complete the E-consent will get a copy of both the consent and patient information emailed to them.
- A copy of the consent is also saved on REDCap.
- Each organisation has a site specific QR code that patients can use to access the E-consent form on their phones or tablets.

The QR code and unique link for organisation name is below:

Scan the QR Code – The E-consent survey link has been converted into a QR code, which can now be scanned by a device that has an app capable of reading QR codes. Once the QR code below is scanned it should take the respondent directly to the survey in a web browser.

- Once you have completed registration, a member of Saving Faces will email you a QR code of the consent form that is unique to your practice or hospital.
- Please print the QR code out and display it where patients can access it.
- Or print copies to hand out with the study information sheet.

- Please keep a signed copy of the consent in your patient notes

Data entry
